Marcy Leverenz is a member of the AAUW Action Fund Lobby Corp. She is from Arlington, VA, retired and is tutoring at a local elementary school. She has been meeting with members of the U.S. Senate in support of the School Safety and Campus Enhancements Act (S.146). She asks us to contact our Senators and urge them to cosponsor this bill.

On March 7 Anne Hedgepeth, AAUW Government Relations Manager, represented us at a celebration - the signing ceremony for the Violence Against Women Reauthorization Act. Pres. Obama spotlighted improvements in the updated bill, championed by AAUW. Three cheers! and let's pat each other on the back!

There have been several victories for women and for education in recent years. Unfortunately, much of the progress is in danger due to the passage on March 21 of the Ryan budget by the House of Representatives. The proposed Senate budget is markedly different, setting up another Fiscal Year 2014 showdown between the 2 chambers. Our input on legislation that matters to us will continue to be critical.
