Studies have repeatedly shown that traumatic experiences are closely associated with a multitude of adult health problems.

Building resilience in both children and adults, especially through positive social relationships and empathy, helps heal the effects of trauma and can help prevent future trauma by breaking generational cycles.

DUES CHANGE FOR NEW MEMBERS

Membership from National has issued the following change for 2019: No Half-Year National Dues. Earlier this year, AAUW stopped offering half-year dues for new national members. Branches, if their bylaws stipulate it, are able to continue this option for state and local dues. New members reported between January 1 and March 15 will be current through June 30, 2019. March 16, 2019 begins FY20. So those who join after the first of the year will no longer pay half price dues. We did charge people joining during that time just half of the state and local dues. The board will look at continuing this policy although state dues are only \$13.00 and branch dues \$8.00 so it wouldn't be much of a savings. National dues will stay at \$59.00.

Dr. Martin Luther King, Jr. Community Holiday Celebration

Presenter: David J. Dennis, Sr. Topic: What does it mean to be an American?



This is not a question only for one indi-

vidual American citizen. What it means to be an American requires a collective perspective. Our Founders placed E Pluribus Unum – out of many, one-- on the nation's seal. The number of people who comprise the whole, as well as the differences among us, have grown dramatically in our 240 year history. Therefore, Civil Rights Activist David Dennis will ask us to reflect upon how we can still become an untied whole out of our great 21st century diversity.

This will be a free admission event open to the public and cosponsored by many community partners.

January Highlights in US Women's History

January 3, 1949 – Margaret Chase Smith (R-Maine) starts her tenure in the Senate, staying in office until 1973, becoming the first woman to serve in both the House and Senate as she served in the House 1940-49.



January 5, 1925 – Nellie Tayloe Ross is inaugurated as the first woman Governor in U.S. history (Gov of WY).

January 7, 1955 – Marian Anderson is the first African American woman to sing at the Metropolitan Opera.





January 25, 1890 – Nellie Bly, journalist, completed her around the world trip in 72 days, 6 hours, 11 minutes, and 14 seconds after setting sail east to prove she could circle the globe in less than 80 days.

January 25, 1980 – Mary Decker became the first woman to run a mile under 4 1/2 minutes, running it at 4:17.55.

January 29, 1926 – Violette Neatly Anderson is the first black woman to practice law before the U.S. Supreme Court.



Public Policy

AAUW Advocacy

AAUW advocates for women in many areas that are currently under attack. Betsy DeVos is trying to roll back Title IX regulations, which would have wide sweeping effects on women who are assaulted on campuses. The gender pay gap, previously thought to be 80% is actually closer to 50% according to the Institute for Women's Policy Research. In July the current administration decided to rollback President Obama's policy on Affirmative Action in schools. All of these issues impact women and girls' experience in the classroom and the workplace.

Equity on campus and in the work world will never emerge, however, unless women have control over their bodies. That is why AAUW continues to advocate that women be able to choose how to manage their reproductive lives, as well as to advocate for increased access to health care and family planning services. Attacks on a woman's right to control her body are no recent phenomenon. Nine days after founder Margaret Sanger opened the country's first birth control clinic in 1916, police raided the clinic, and put Sanger in jail for 30 days. Fast forward to March, 2017, when Mike Pence cast the tie-breaking vote to repeal an Obama-era protection for Planned Parenthood patients who get family planning care through Title X. In May, 2018, the Trump administration announced a "gag rule" which gravely restricts access to reproductive rights and attempts to block Medicaid patients from care at Planned Parenthood health centers. By November 7, 2018, the administration finalized rules to allow employers and universities to refuse to cover birth control in their health insurance plans.



AAUW continues to advocate for women's reproductive health. In May 2018 in response to the "gag rule," AAUW joined with



more than 110 organizations in a letter to Alex Azar, the U.S. Secretary of Health and Human Services, asking him "to reject any proposals that would restrict access to high-quality, affordable family planning care under Title X, including the harmful domestic gag rule." AAUW supports improving public funding for reproductive health and ensuring access to legally prescribed or available contraceptives.
